from the original purchase date, under normal use and service conditions, the reinforced membrane for swimming pool Aquasense, Aquastone, Aquadecor, Aquacolor (hereinafter "the Products") will be watertight and will not deteriorate to the point of causing leaks through the pool liner.

THIS WARRANTY SHALL NOT COVER LINER DISCOLORATION, VARIATION IN TONE OF THE PRINTED DESIGNS, STAINS, LOSS OF GLOSS, FADING OR BLEACHING. CGT SHALL NOT BE RESPONSIBLE FOR COSTS AND EXPENSES INCURRED WITH RESPECT TO THE REMOVAL OF DEFECTIVE MEMBRANES OR THE INSTALLATION OF REPLACEMENT MATERIALS. THIS WARRANTY DOES NOT COVER THE COSTS OF LABOR, WATER FILLING AND CHEMICALS.

Original Purchaser: The Original Purchaser must purchase the Products directly from CGT this warranty to be valid.
